# HORIZON EUROPE PROPOSAL APPLICATION FUND

## GUIDELINES

## 1) OBJECTIVE

The main objective of this grant scheme is to stimulate cooperation and joint project proposals in the frame of Horizon Europe programme between R&I actors from the European Union (EU) and Kosovo. This grant scheme covers parts of the costs of the Kosovan researchers in applying for a Horizon Europe project proposal only and will be disbursed on basis of clear criteria and a review procedure.

Within this grant scheme, SHER will award twenty grants (each 1 500 EUR) to applicants. This will provide grants to researchers for covering technical and/or logistical support for the development of the project proposal for Horizon Europe, based on successful submission.

## 2) <u>ELIGIBILITY</u>

Eligible applicants for this call are: Universities; Research Institutes; Individual Researchers, Companies, Small and Medium Enterprises and Civil Society Organizations (CSOs) from Kosovo.

The applicants must fulfill the following:

- The applicant must have a submitted a project proposal as part of consortium under *Horizon Europe*;
- The project proposal submitted to *Horizon Europe* needs to be in line with Kosovo's priorities in the field of R&I;
- The collaborative project proposals submitted to *Horizon Europe* must have scientific basis (state of the art concerning the specific research topics, gaps to be filled in the current knowledge, relevance of proposed activities) and the expected impact of the research;
- Evaluation Summary Report (ESR) received by the European Commission (EC) which proofs that the submitted proposal is ranked over the threshold set by the EC for the particular Horizon Europe call.
- The project proposal submitted to *Horizon Europe* must provide information on how the R&I activities are being promoted.

#### 3) **IMPLEMENTATION**

The grant holder will have to accept the obligation to provide SHER all the information requested about the outcome of their activities. The requested grant is 1 500 EUR and it is covered on reimbursement basis.

The grant will be transferred to the grantee bank account (as indicated in the application form). The distribution of the grant budget will be administered by SHER.

Note: The projects can be retroactively reimbursed, only from 01 January 2025 onwards.

#### 4) DURATION AND EVALUATION

The call will be open from 1<sup>st</sup> of February 2025 until 31<sup>st</sup> of May 2027. The remaining grants will be evaluated based on national priorities of Kosova and will prioritize projects in area of Research and Innovation Action (RIA).

The eligible applications will be evaluated by a selection committee composed of representatives of:

- Ministry of Education, Science, Technology and Innovation (MESTI);
- ZSI (Centre for Social Innovation); and
- SHER Programme.

The final decision on granting the applications will made solely by the selection committee.
